SELLER AGREES TO SELL BUYER THE AFOREMENTIONED PUPPY FOR THE SUM OF \$ _____

Seller/Breeder has provided all necessary vaccinations, worming and veterinarian care to date of sale.

The puppy is in good health and free from any serious health issues as certifying health certificate indicates by licensed veterinarian. Breeder/Seller does not cover communicable diseases that were contracted after the puppy leaves. Breeder/Seller does not guarantee size, color or coat type

TWO YEAR HEALTH GUARANTEE

Seller/Breeder guarantees this puppy is in good health at the time of purchase and has received appropriate vaccinations and care. If a serious genetic defect is found by your veterinarian within two years from the birthdate, either appropriate procedures to correct the problem will be paid for by the seller not to exceed the purchase price, or the puppy purchase price will be refunded. For purchase price refund, we will need supporting documents from your veterinarian. We will also need the name and phone number of your veterinarian in case there are any questions. After receiving the documentation, it will be submitted to seller's veterinarian for review. If a genetic problem is determined to be present, the puppy purchase price will be refunded. Before any surgeries or treatments are done on the puppy found to have genetic defects, we are to be contacted. Seller is not responsible for any buyer's veterinarian bills.

1). CONDITIONS OF SALE- BUYER

Buyer agrees to have the puppy seen by a qualified licensed veterinarian for a well puppy check within 7 days from date of purchase/delivery excluding weekends and holidays.





Buyer agrees to do all follow up vaccinations and to limit the puppy's exposure until all three/four sets of vaccinations have been administered.

Buyer agrees that this puppy is not intended for breeding purposes.

2). If at any time the Buyer can no longer retain possession of this dog, the Seller is to be notified and given first option of resuming full ownership of dog in order for the Seller to locate this dog a new home. Refunds, if any, will be at the discretion of the Breeder/ Seller. The dog will be returned with all medical records. Should any circumstances arise that could affect the quality of life of

the dog, the breeder/seller is to be informed so that they may participate in determining the future of the dog. The Breeder/ Seller reserves the right to approve/prohibit any transfer of this animal to a third party. Under no circumstances will this dog be sold, leased, traded or given away to any pet shop, research laboratory, animal shelter or similar facility.

3). The Buyer agrees to contact the Seller immediately if any questions or concerns arise about the dog, such as housing, diet, or health. The buyer agrees to keep the seller informed of any treatment as it occurs. This provides the Breeder/Seller with an opportunity to follow up on puppies and gives us important feedback and information on the health or our dogs for future generations.

4). The Buyers agree not to use this animal for breeding and agree to have it spayed/neutered at the age recommended by their veterinarian (usually 7 months to 1 year of age). This dog will be on limited CKC or AALA registration until such time as proof of spay/neuter is provided to Seller. Registration papers will be transferred to Buyer for Puppy: _____ microchip AKC # _____ at that time.

5). It is understood at the time of sale that this is a pet quality dog representative of it's breed. BUYER is required to have said puppy's surgical sterilization completed on or before 05/18/2018 (one year of age).

Said puppy is not to be bred under any circumstances without the express written permission of Family Labradoodles or their representatives.

A monetary penalty of seven thousand five hundred dollars will be charged if the puppy is used for breeding.

PROOF OF STERIALIZATION

Certification/proof of spay/neuter must be submitted to Family Labradoodles on Veteraniary Letterhead on/before one year of age. In the event that extenuating circumstances prevent this medical procedure, Buyer will advise Seller in writing.

The preceding paragraphs contain conditions established by the Seller to ensure the wellbeing of the puppy/dog. The Buyer's agreements will continue for the duration of the dog's life and the Seller will have the right to enforce the agreements.
